Since its introduction in 2003, SOS Africa has supported 44 disadvantaged children, from grades 1 to 12, with a personal education programme tailored specifically to their needs and a holistic approach which enables children to break the cycle of poverty and reach their full potential.

Founder of SOS Africa, Matt Crowcombe commented: "The sponsorship provided by Jay and his team at Cover and Legal will enable us to provide essential education and care to significant numbers of underprivileged children from the local township communities. Thanks to this support we can help these children break the cycle of poverty and fulfil their potential. This sponsorship will create a lasting legacy of empowerment through education.

"We cannot wait to welcome Jay and his team to visit the new education centre and meet the programmes many beneficiaries early next year. We are also very excited about the new partnership which has been forged between Cover and Legal and SOS Africa and the positive impact it will have upon South Africa's future generations."

Construction of the aftercare building has now begun and the building itself will open in January 2017.
