



We use Artificial Intelligence (AI) to provide more reliable and more up-to-date ESG insights on our platform. Companies with a bad performance on ESG are more likely to have issues that potentially can lead to financial and reputational damage. That is why we provide investors, companies and individuals with the information needed to make informed decisions and improve their risk management strategy.



Environment, Social and Governance (ESG)

ESG indicators provide a detailed view on how sustainable a company is operating and how well the company is preventing and managing issues. In our analysis we look at company policies, operational statistics and incidents that occurred. Environmental issues include pollution, climate change, chemical accidents and use of scarce resources. Social issues are for example child labor, mistreatment of employees and human rights violations. Governance issues that can occur are corruption, mismanagement by the board and lack of transparency.

Sustainability Score



The key figures provide raw values for important indicators. The infographics make them easy to understand for everyone.


In-depth Comparison

Issue tracking


The analysis identifies trends by tracking issues long-term. If the same type of incidents happen more often, it leads to a higher company risk score.


Risk signals

Portfolio Manager




Technology
